Founded by Kenny Goss and the late music legend George Michael, the Foundation exists to educate, engage and inspire audiences by presenting exhibitions of British contemporary art, and providing vast resources, educational programs, and scholarships to aspiring artists.

Ms. Goss also serves as a Board Chair of the North Texas and Central Region U.S. fund for UNICEF, and serves on The Family Place Foundation Board and Nasher Sculpture Center PAC. She is a former Board Member of Dallas Contemporary, Co-Founder of MTV RE:DEFINE, and she has chaired events for U.S. Fund for UNICEF, Planned Parenthood of North Texas, Dallas Women's Foundation, Dallas Contemporary, and TWO x TWO for AIDS & Art, benefitting the DMA and amfAR among others. She earned her BBA in Finance at the University of Texas at Austin.
